
Subject: - Restructuring the posts of Heads of Department Cadre.

The restructure of the Odisha Ministerial Services (Assistants and Section Officers) cadre in the offices of the Heads of Departments and the Odisha Heads of Departments Establishment Officers Cadre has been made vide this Deptt. Resolution No.2372/Gen, Dated 24.01.2019.

As per the provisions prescribed in the said Resolution, Government have been pleased to abolish 351 posts of Senior Assistant(re-designated as A.S.O) out of the existing cadre strength of 2016(two thousand sixteen) posts of Sr. Asst. and in lieu of that, 351 posts at the higher level i.e at the level of Section Officer, Establishment Officer, Administrative Officer and Senior Administrative Officer are being created proportionately in each Heads of Departments. After abolition and creation of posts at different level, the revised cadre strength in detail under each Heads of Departments is annexed here with as Annexure-A.
