RESOLUTION.

Sub:- Revision of cadre strength of the Orissa Administrative Service (Superior Administrative Grade), (Senior Grade in Super Time Scale), (Super Time Scale) & Class-I Senior Branch).

The strength of the cadres of OAS (Senior Grade in Super Time Scale), (Super Time Scale) & Class-I (Senior Branch) was last revised and fixed at 57 & 129 respectively in General Administration Department Resolution No-40561/Gen dt.21.11.92. Subsequently, a cadre of Superior Administrative Grade of OAS with 4 unspecified posts of Additional Secret was constituted in General Administration Department Resolution No-30352/Gen, dt. 28.11.96.

2. In G.A. Department Resolution 3698 dt.17.2.94, it was decided that 10 % of the posts of District Magistrate and Collectors in the State subject to a maximum of three posts is to be manned by OAS, Officers of Joint Secretary's level. Accordingly three posts in OAS (Super Time Scale) were created until further orders vide G.A. Department sanction order No-4873, dt. 3.3.94 as temporary addition to the cadre.

3. A Cadre Management Committee under the chairmanship of the Member, Board of Revenue, Orissa, Cuttack was constituted in G.A. Deptt. O.O No-21864, dt.17.3.98 to review the strength of the OAS Class-I (Sr.Branch), Super Time Scale Senior Grade in Super Time Scale and Superior Administrative Grade Cadres and submit its report. The Committee with regard to the provisions laid down under the Finance Deptt circular.No-11172/F, dated 20.3.98 on observance of economy and the prevailing necessity of the administration, have recommended to abolish the following 19 posts in OAS-I (Sr. Cadre while revising the cadre strengths.

The Committee also recommended that the post of Addl. Inspector General of Prisons in the rank of OAS(S.G) may cease to operate and in lieu thereof, an unspecified post of Addl. Secretary to Govt., may be created. Similarly, the post of Addl. Commissioner, Land Reforms in the rank of OAS(S.G) may cease to operate and in lieu thereof, a post of Addl. Inspector General, Registration, Orissa, Cuttack may be created in the OAS(S.G) Cadre. Besides, the post of Addl. Director, Institutional Finance & Ex-Officio Joint Secretary to Govt., Finance Department provided in the cadre of OAS (Super Time Scale) may be abolished.

4. After careful consideration of the above recommendations, Government have been pleased to accept the same with regard to abolition and creation of the aforesaid posts and have agreed to include six posts of District Magistrates

and Collector, provisionally in O.A.S. (Super Time Scale) Cadre and decided that the cadre schedules of O.A.S. (Super Administrative Grade) (Senior Grade in Super Time Scale) (Super Time Scale) and Class-I (Senior Branch) shall be revised as follows:-
