Ltd., Paradeep, Jagatsinghpur under Jagatsinghpur Excise District"**, "M/s Fortune Spirits Ltd., Narayanpur, Gopalpur-on-sea, Berhampur, Ganjam under Ganjam District" may be read as **"M/s Fortune Spirits Ltd., Narayanpur, Gopalpur-on-sea, Berhampur, Ganjam under Berhampur Excise District"** and "M/s Kwality
