OFFICE MEMORANDUM

No.IVS/3-47/2003 1499/LE., Bhubaneswar, dtd. 7/02/2003.

Sub:- Sanction of E.O.L. to in-service Doctors for prosecuting P.G. study before completion of one year continuous service on regular basis.

In terms of Rule 13(3) of the Orissa Leave Rule, 1966, a Government servant not in permanent employment is entitled to E.O.L. for higher studies or training to improve his/her professional knowledge from the date of relief till the date of resumption of duties on return from study/training provided that he/she has completed a minimum period of one year continuous service on the date of relief.

2. The above stipulation i.e. "completion of one year continuous service" has been relaxed in respect of doctors working under administrative control of Health and Family Welfare Department in Health & F.W. Department Memo No. 34703/H dt. 13.10.92 with concurrence of Finance Department to the effect that the in-service doctors appointed on regular basis can avail themselves of E.O.L. irrespective of whether they have completed one year of service or not on execution of required bond before their relief.

3. But the doctors working under administrative control of Labour & Employment Department who are similarly situated with the doctors working under Health & F.W. Department, are not getting the above benefit of E.O.L. while prosecuting higher study or training.

4. Government after careful consideration of the above facts have been pleased to decide that the inservice doctors appointed on regular basis can avail themselves of E.O.L. for prosecuting higher study or training irrespective of whether they have completed one year service or not, on execution of the required bond before their relief.

5. This has been concurred in by Finance Department in their UOR No. 4036/PSF dt. 6.11.2002 .
