RESOLUTION

Dated the 16th March 1991

SUBJECT:—New Job Policy of Government for recruitment to all Class III Non-gazetted and specially declared gazetted posts.

In order to ensure impartiality and fair play in filling up vacancies of various services/Posts by the appointing authorities, Government have decided vide their Resolution No. 32538-Gen., dated the 16th November 1988 that these posts should be filled up by way of recruitment conducted by the Directorate of Examinations under the Board of Revenue, Orissa, Cuttack. Accordingly, Government in the above Resolution have laid down the procedure to be followed for selection of personnel for various services and common category posts at the state level both in respect of Specially Declared Gazetted and Class III Non-gazetted services and posts, including extension and ministerial cadres, and also to control and regulate selections in respect of District/Range/Circle level services and posts.

2. Government have reviewed the working of the Directorate of Examinations, Board of Revenue and have decided to abolish the same with immediate effect and to replace it by constituting a Subordinate Staff Selection Commission for recruitment to all non-gazetted and Specially Declared Gazetted posts which form State Cadres. Accordingly, action is being taken to set up a Subordinate Staff Selection Commission and therefore, this Department Resolution referred to above is superseded.

3. Pending establishment of the Subordinate Staff Selection Commission it has been decided by Government that the respective Departments/Heads of Departments will recruit candidates to all Non-gazetted and Specially Declared Gazetted posts which form State Cadres as it was prior to the setting up of the Directorate of Examinations.

4. It has been further decided by Government that for appointment to Class III District Cadre posts recruitment will be done at the District level to facilitate local candidates being selected.

5. To ensure impartiality and fair play in conducting such recruitment to Class III Non-gazetted posts and services at the Divisional/Range and District levels the procedure as prescribed in this Department Resolution No. 5248-Gen., dated the 27th February 1985 and Resolution No. 21671, dated the 17th September 1987, respectively shall have to be followed meticulously by the appointing authorities and the list of successful candidates shall have to be limited to the number of vacancies notified.

6. Selection to all categories of Class IV posts shall be regulated in pursuance of the instructions issued in this Department letter No. 11752-Gen., dated the 19th April 1989, read with this Department letter No. 29815(130), dated the 22nd September 1989.

7. It has also come to the notice of Government that the Director of Examinations under the Board of Revenue had already conducted the recruitment examination on 21st October 1990 for appointment of Junior Assistants in different Heads of Departments and the process of selection had reached the final stages,

8. In the circumstances Governments have decided that the Director of Examinations should complete the process of selection in respect of the above examination immediately and allot successful candidates to the Heads of Departments concerned limiting the same to number of vacancies for which requisitions were received.

9. This supersedes this Department Resolution No. 32538, dated the 16th November 1988 and necessary amendments shall be made in the relevant Recruitment Rules, accordingly.

ORDER—Ordered that this Resolution be published in the *Orissa Gazette* and copies thereof be forwarded to all Departments of Government/all Heads of Departments/all Collectors/Accountant-General, Orissa/Secretary, Orissa Public Service Commission, Cuttack/Registrar, Orissa Administrative Tribunal/Secretary to Governor.
