No. 21143-Edn.-I-(OMT)-60/2007/SSD.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Orissa is pleased to make the following rules further to amend the Orissa Subordinate Tribal Welfare Education (Recruitment and Conditions of Service) Rules, 1993, namely : —

1. (1) These rules may be called the Orissa Subordinate Tribal Welfare Education (Recruitment and Conditions of Service) Amendment Rules, 2008.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Subordinate Tribal Welfare Education (Recruitment and Conditions of Service) Rules, 1993 in rule 5 in sub-rule (3),

(i) for the word, letters and comma "and B.A. B. Ed." the following word and letters shall be substituted, namely : — "B.A. B. Ed. and B. Com B. Ed." and

(ii) after item (vii), the following items shall be inserted, namely : —

(viii) Physical Education Teachers (PET)/Mistress

(ix) Head Sevaks/Head Sevikas

(x) Carpentry Teachers

(xi) Music Teachers/Mistress

(xii) Weaving Teachers/Mistress."
