NOTIFICATION

No. ID-41/2000. 20529 / Gen., In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Administrative Service, Class-I (Recruitment to Senior Branch) Rules, 1979, namely:-

1. (1) These rules may be called the Orissa Administrative Service Group-A (Recruitment to Senior Branch) (Amendment) Rules, 2002.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Administrative Service Class-I (Recruitment to Senior Branch) Rules, 1979 (hereinafter referred to as the said rules), for the word and figure "Class-I" wherever they occur the word and letter "Group-A" shall be substituted.

3. In the said rules, in sub-rule (1) of rule-2, the following clause shall be added, namely:-

"(g) Year means a calendar year."

In the said rules, for rule-5, the following rule shall be substituted, namely:-

"5. Selection by the Board-(1) The Selection Board shall ordinarily meet before the 31st day of January of each year and prepare a list of such members of Orissa Administrative Service Group-A (Junior Branch) who are considered by them to be suitable for appointment to the Service.

(2) The Selection Board for preparation of the list shall follow the provisions of the Orissa Civil Services (zone of consideration for promotion) Rules, 1988 and the Orissa Civil Services (Criteria for promotion) Rules, 1992;

(3) The Selection Board shall not consider the case of a member of the Orissa Administrative Service Group-A (Junior Branch) unless, on the first day of January of the year or when it meets, he is substantive in service in the Orissa Administrative Service, Group-A (Junior Branch) or has completed ten years of service in the Orissa Administrative Service, Group-B and Orissa Administrative Service, Group-A (Junior Branch) taken together;

Provided that a member of Orissa Administrative Service, Group-A (Junior Branch) who has already been appointed as probationer in the Orissa Administrative Service, Group-A (Senior Branch) shall not be considered by the Selection Board for appointment to the service.
