- i) Preparation of the road-map for simplification of Processing of Pension cases of Government employees in a way that the PPOs of retiring employees are to be delivered by Head of Office on the day of retirement.
- ii) To examine the possibilities for introduction of common nomination for GPF/Gratuity/Commuted value of Pension/Life Time Arrear of Pension.

- iii) Possibilities of introduction of self-attestation in place of attestation by Gazetted Officers.
- iv) Simplification of procedure for withdrawal of Final GPF.
- v) Deliberate on any other issues required to be addressed for simplification of process relating to sanction of Final Pension.

The Committee will submit its report within a period of two months.
