No. SC(R) – 20/2009 - 1476 /Gen. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Civil Services (Reservation of vacancies for Women in Public Services) Rules, 1994, namely :-

1. (1) These rules may be called the Orissa Civil Services (Reservation of vacancies for Women in Public Services) Amendment, Rules, 2009.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Civil Services (Reservation of vacancies for Women in Public Services) Rules, 1994 (hereinafter referred to as the said rules), in rules 2 and 3 the words, commas and the numerals "in the rank of Class-II, specially declared gazetted, Class-III and Class-IV" wherever appear shall be omitted.

3. In the said rules, in rule 4, in sub-rules (1) and (2),

( i ) the words, commas and numerals "Class-II, specially declared gazetted, Class-III and Class-IV " wherever appear shall be omitted and


( ii ) after the words " a year in " and " vacancies in " respectively appearing therein, the following shall respectively be substituted, namely :-

"any civil"




