No.GAD-SER2-RB-0002-2020- 17475 /Gen. In exercise of the powers conferred by rule 14 of the Odisha Government Rules of Business made under clause (3) of article 166 of the Constitution of India, the Governor of Odisha hereby makes the following amendment to the instructions issued under rule 14 of the said Rules of Business, namely:-

AMENDMENT

In Instructions issued under rule 14 of the Odisha Government Rules of Business, after instructions under Part VI, the following part shall be inserted, namely:-

"PART VIA

The Electronics and Information Technology Department

52A. All Administrative Departments shall consult the Electronics & Information Technology Department on-

- Rules of Business order*
Guard file
- (a) creation of any new/upgrade Data Centre or Call Centre;
 - (b) creation of Network Infrastructure by any organization;
 - (c) creation of DPR for e-Governance initiatives;
 - (d) establishment of Server Room or Data Centre and VC Solution Procurement of Server or related network infrastructure such as Router, Firewall, UTM etc;
 - (e) deployment of mobile and web applications;
 - (f) any innovative projects related to Electronics and Information Technology;
 - (g) purchase of any proprietary and specialized software or tools; and
 - (h) conceptualization of new e-Governance projects.

52B. The views of the Electronics & Information Technology Department shall be brought to the permanent record of the Department to which the case belongs and shall form part of the case.

52C. The Electronics Information Technology Department may, in general or special order, specify cases in which its approval may be presumed to have been given."


