**RESOLUTION**

No. **GAD-SC-GCS-0121-2017-3894** /Gen. - In pursuance of the powers conferred by rule-8 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962 and in supersession to the General Administration Department Resolution No.18861/Gen., Dated 08<sup>th</sup> July, 2013 read with ORDER No. 31518/Gen., dated 7<sup>th</sup> November, 2013; except as respects things done or omitted to be done before such supersession, the Governor of Odisha hereby directs that all Civil Posts in the State shall be classified into such categories as per the Levels in the Pay Matrix mentioned in Column (3) attached to such posts as admissible against such categories of posts so classified in the Table given below, namely:—

The Departments of Government concerned shall accordingly amend the relevant provisions in the Acts, Statutory Rules, Rules regulating the Recruitment and Conditions of Service, Regulations, Codes, Manuals, Resolutions, Office Memoranda and all other executive instructions which contain any provision contrary to the classification specified supra.
