NOTIFICATION

No. GAD-COOD-CORDS-0002/2018- 22666 /Gen., Dtd. 13.08.2019

In exercise of the powers conferred by section 5 read with section 4A of the Odisha Official Language Act, 1954 (Odisha Act 14 of 1954), the State Government do hereby make the following rules to amend the Odisha Official Language Rules, 2016, namely:—

1. **Short title and Commencement.** — (1) These rules may be called the Odisha Official Language (Amendment) Rules, 2019.

(2) They shall come into force on the date of their publication in the Odisha Gazette.


2. In the Odisha Official Language Rules, 2016, after Rule 5, the following rule shall be inserted, namely:—

“5A. **Rewards or Punishment.** — (1) For extensive use of Odia as the official language for all or any of the official purposes in the State of Odisha, the officials as well as Administrative Departments shall be rewarded.

(2) In case of any substantial and persistent dereliction in the use of Odia as the official language for official purposes, action as deemed fit under the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962 shall be initiated against the erring officials.

(3) In case of officials of All India Services and of Central Civil Services working under the State Government, action shall be initiated under the provisions of the relevant disciplinary Rules.”

(୨) ଓଡ଼ିଶା ଗେଜେଟରେ ପ୍ରକାଶନ ତାରିଖ ଠାରୁ ଏହା ବଳବତ୍ତର ହେବ ।

୨. ଓଡ଼ିଶା ସରକାରୀ ଭାଷା ଅଧିନିୟମ, ୨୦୧୬ର ନିୟମ ୫ ପରେ ନିମ୍ନଲିଖିତ ନିୟମ ଅନ୍ତର୍ଭାଗ କରାଯିବ :—
