NOTIFICATION

Dated, Bhubaneswar the 8th Sep^r 1998

No.OSSC-21/98 25704 /Gen., In exercise of the powers conferred by the proviso to article 309 of the Constitution of India the Governor of Orissa is pleased to make the following rules further to amend the Orissa Staff Selection Commission (Method of Recruitment and Conditions of Service of the Chairman and Members) Rules, 1995, namely :-

1. (1) These rules may be called the Orissa Staff Selection Commission (Method of Recruitment and Conditions of Service of the Chairman and Members) Amendment Rules, 1998.

(2) They shall come into force with effect from 1st day of January, 1996.
2. In the Orissa Staff Selection Commission (Method of Recruitment and Conditions of Service of the Chairman and Members) Rules, 1995 (hereinafter referred to as the said rules), in rule-5 for sub-rule (1) excluding the provisos, the following sub-rule shall be substituted, namely :-

"(1) The Chairman of the Commission shall receive a pay of rupees Twenty thousand four hundred fifty (fixed) per month and the Member of the Commission shall receive a pay of rupees Nineteen thousand five hundred (fixed) per month."

3. In the said rules, for rule 7, the following rule shall be substituted, namely :-

"(1) The Chairman and Member of the Commission who on the date of appointment was in service in the Government and retired from the said service are entitled to get pension not exceeding Rs 3,500/- per annum, for life, if they have completed not less than 2 years of service as Chairman or Member, as the case may be, in the Commission,

NO pension shall be payable to Chairman or Member on his removal from service. If Chairman or Member who have completed two years of service or more resigns from his office and such resignation is accepted by the Government, he shall be entitled to pension as admissible under these rules. If Chairman or Member has completed two years, three years, four years of service, he shall be entitled for 2/5th, 3/5th or 4/5th respectively of the full pension which is payable to him.

(2) Where the Chairman or the Member, who on the date of appointment was not in service of the Union or in any State, he is entitled to get pension of Rs10,000/- and Rs7,500/- per annum respectively for life if he has completed five years of service in the Commission and subject to other provisions as contained in sub-rule (1) above.

(3) The Chairman and Member shall be entitled to the benefit of gratuity at the rate of 15days pay for each completed year of service, if they have completed not less than two years of service in the Commission."
