RESOLUTION

Sub.:- Revision of pay scale of Library Attendant and Laboratory Attendant from Level-2 to Level-3 of the Pay Matrix under ORSP Rules, 2017.

The post of Library Attendant and Laboratory Attendant having pay in Pay Band -1S (₹4440-7440) plus Grade Pay of ₹1650 under ORSP Rules, 2008 has been categorised as Group-C post. The said Pay Band was changed to ₹4440-14680 in FD Resolution No.29318/F, dated 01.7.2010. The pay scale and grade pay was further revised to ₹4930-14680 and ₹1750 in F.D Resolution No.36518/F, dated 30.10.2012 w.e.f 01.10.2012. It was last revised at Pay Band -1S (₹4930-14680) with Grade Pay ₹1775 w.e.f. 01.12.2015 vide FD Resolution No.5799/F, dated 08.3.2016.

After implementation of ORSP Rules, 2017 w.e.f. 01.01.2016, the corresponding scale of pay of Pay Band -1S (₹4930-14680) plus Grade Pay of ₹1775 was revised to Level-2 in the Pay Matrix of ORSP Rules, 2017. But, the scale of pay of Level-2 was categorised as Group-D scale vide GA & PG Department Resolution No.3894/Gen, dated 9.2.2018. As such, the Library Attendants and Laboratory Attendants being Group-C employees are placed in the Group-D category i.e. Level-2 in the Pay Matrix. This issue was under consideration of the Government for some time past.

Government, after careful consideration, have been pleased to decide that the Library Attendant and Laboratory Attendant being Group-C post as per the Odisha Laboratory Attendant Service, Group 'C' (Methods of Recruitment and Conditions of Service) Rules, 2012 and the Odisha Library Attendant Service, Group 'C' (Methods of Recruitment and Conditions of Service) Rules, 2012, will be placed at **Level-3** of the Pay Matrix under ORSP Rules, 2017 instead of Level-2.

This Resolution shall take effect from the date of its issue.
