RESOLUTION

No.2R/1-39/2004 B609 /Gen.Bhubaneswar, dated the 2nd Mar, 2005.

Sub: Nomination of Officers as member to D.P.Cs to consider the promotion cases of Junior Assistants, Senior Assistants, Section Officers in the offices of the Heads of Departments.

Rule 16(1)(c) of the Orissa Ministerial Service (method of recruitment and condition of service of Assistants and Section Officers in the offices of the Heads of Departments) Rules, 1994 provides that the Deputy Secretary of any Department of Secretariat other than the Administrative Department is required to act as member of the Departmental Promotion Committee (D.P.C). G.A. Department vide their letter No.9711/Gen., dated 04.04.2003 have issued instructions that the Departments should associate the Deputy Secretaries of other Departments in the Departmental Promotion Committee meetings of the Heads of Departments since it is not practicable to spare Deputy Secretaries from G.A. Department to attend the said Departmental Promotion Committee meetings as they are tied down with day to day important official work.

2. It is further felt that in the absence of specific instruction, it is administratively difficult and cumbersome to keep requesting for a Deputy Secretary from one Department or another to attend as member in the Departmental Promotion Committee meetings of the Heads of Department.

3. To obviate the above difficulties, Government have been pleased to decide that the Administrative Departments/ Heads of Departments will associate the Deputy Secretary of the Departments as noted below to act as member in the Departmental Promotion Committee meetings as required under Rule 16(1)(c) of the O.M.S. Rule, 1994.

ORDER:

Ordered that this resolution be published in the extra-ordinary issue in the Orissa Gazette and copies thereof be forwarded to all Departments of Government/ All Heads of Departments/ Registrar, Orissa High Court, Cuttack/ Registrar, O.A.T./ Secretary, Staff Selection Commission for information and necessary action.






