Resolution No.32242-19/85 dated 22.8.85 (Paragrahp-24), Government
have allowed upgradation of one third of the posts of Section
Officer as Section Officer Level-I for the Heads of Department
with the scale of Rs.1600-2500/- and have designated the
remaining posts as Section Officer Level-II. In view of this
decision, it is necessary to amend General Administration
Department Resolution No.24/Gen., dated 1.1.85 to maintain
uniformity in matters of promotion to the post of Section
Officer Level-I. Government after careful consideration and in
partial modification of the aforesaid G.A. Department Resolution
dated 1st January 1985 have decided that the following procedure
shall be followed to fill up the post of Section Officer Level-I
in the Heads of Department.

1. The post of Section Officer Level-I shall
be filled up from among the Section Officers, Level-II. No
Section Officer Level-II shall be eligible for selection of
Section Officer, Level-I unless he has completed (not less than)
eight years of continuous service as Section Officer, Level-II
on the 1st Day of January of the year on which the Selection
Board meets.

2. The DPC/Selection Board for promotion to
the post of Section Officer Level-I shall consist of the
following members.
