NOTIFICATION.

Bhubaneswar dated the 11th March 1992.

No.2R/1-22/92. 7240 /Gen., In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules to amend the Orissa Civil Services (Combined Competitive Recruitment Examination) Rules, 1991, namely :-

1. (1) These rules may be called the Orissa Civil Services (Combined Competitive Recruitment Examination) Amendment Rules 1992.

(2) They shall come into force on the date of their publication in the Orissa Gazette.

2. In the Orissa Civil Services(Combined Competitive Recruitment Examination)Rules, 1991 (hereinafter referred to as the said rules), to rule 13, the following proviso shall be added, namely:-

"Provided that a candidate who has been selected for appointment to any of the posts or Services mentioned under category-II in column 2 of Schedule-I may, subject to his eligibility, be allowed to compete again for any Class-II Service or Services mentioned under Category-I in column 2 of the said Schedule ".

3. In the said rules, in schedule-I,-

(i) In column 2,-

(a) the entries appearing in columns 2 and 3 against serial numbers 3 and 6 shall be omitted ;

(b) for the brackets and words "for Assistant Employment Officer)(Specially declared Gazetted)", the brackets and words "(Junior Employment Officer)"shall be substituted ; and

(ii) In column 3, for the words and figures

"The Orissa Sub-ordinate Finance Services Rules, 1951", the words, brackets and figure "The Orissa Sub-ordinate Finance Service (Commercial Tax Branch)

(Recruitment and Conditions of Service) Rules, 1988" shall be substituted.

4. In the said rules, in Schedule-III, in the Note appearing under item 2, -

- (i) I in sub-clause (a) of clause(i), the comma & word "Linguistics" shall be omitted ;and
- (ii) after sub-clause (e), the following sub-clauses shall be inserted, namely :-

- "(f) Commerce, Accountancy and Management,
- (g) Agriculture, and Animal Husbandry and veterinary Science.
- (h) Management and Public Administration".

5. In the said rules, in Schedule-V, the entries appearing under columns 2 and 3 against serial numbers 4 and 5 shall be omitted.
