Bhubaneswar dated the 11th April, 2022

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Services (Criteria for promotion) Rules, 1992, namely:—

1. Short title and commencement.— (1) These rules may be called the Odisha Civil Services (Criteria for Promotion) Amendment Rules, 2022.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Civil Services (Criteria for Promotion) Rules, 1992, in rule 3,—

G.C
(i) in clause (c), in Note-I, after the words "departmental action" and before the words "and other confidential reports", the comma and the words ",Property return" shall be inserted.

(ii) for clause (d) including the proviso thereto, the following clause shall be substituted, namely:—

"(d) The PAR, the vigilance reports, papers relating to departmental action, property return and other confidential reports shall be forwarded online to avoid delay:

Provided that above reports except property return shall not be required in respect of Group-'D' employees."
