In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha District and Subordinate Courts' Non-Judicial Staff Services (Method of Recruitment and Conditions of Service ) Rules, 2008, namely:-

- 1. Short title and commencement:** – (1) These rules may be called the Odisha District and Subordinate Courts' Non-Judicial Staff Services (Method of Recruitment and Conditions of Service ) Amendment Rules, 2022.  
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha District and Subordinate Courts' Non-Judicial Staff Services (Method of Recruitment and Conditions of Service) Rules, 2008, for the word "Daftri" wherever it occurs, the words "Binder" shall be substituted.
