
Consequent upon enhancement of the Bench Mark Value of land in respect of different mouzas under Bhubaneswar Tahasil by the District Level Valuation Committee w.e.f 01.04.2024, Government have been pleased to revise the premium of Government land fixed earlier by this Department vide Order No.12666/CA, Dt.07.05.2022 at par with the Bench Mark Value adopted by the District Sub-Registrar, Khordha, Bhubaneswar/Sub-Registrar, Khandagiri within the limits of Bhubaneswar Municipal Corporation with effect from the date of issue of this order.

The pre-revised rate of premium shall, however, be applicable for the following categories of the cases.

1. Conversion applications under the scheme of conversion/Transfer applications pending as on the date of this revision shall be disposed of as per the pre-revised rate of premium prevailing as on the date of application. But, revised rate of premium shall be applicable, if the Conversion application/Transfer application is pending for the fault of the applicant.
2. Land allotted by Government before this revision, but for which necessary legal formalities have not been completed for no fault of the allottee concerned.
3. Cases where allotment of land has been made by the Government before this revision, but the entire consideration amount has not been paid with the approval of the Government or instalments as fixed by the Government have not fallen due.

The decision of the Government in the G.A. & P.G. Department with regard to fixation of conversion fee/consent fee for transfer of the plot/rate of land premium and on other similar matters shall be final and binding.
