For implementation of 10% Economically Weaker Sections( EWS) reservation quota for the academic session, 2019-20 for admission into Medical Education Institutions under Constitution Amendment (One Hundred and Third Amendment) Act, 2019 dated 12.01.2019, the Govt. of India, Ministry of Health & Family Welfare have increased the seats in the following Medical Colleges & Hospitals as communicated vide L.No.U-12012/350/2019-ME.I[FTS.8013875] dtd.21.06.2019.

Now, after careful consideration of the above recommendation, Government of Odisha have been pleased to reserve 10 percent seats for Economically Weaker Sections(EWS) for taking admission in the above three Medical Institutions which shall be over and above the existing reservations as mentioned in this Department letter no.2243 dtd22.01.2003.

The extent of reservation for EWS shall be in such a manner that the number of seats made available to the Economically Weaker Section(EWS) shall not reduce the number and percentage of reservation provided for the categories as mentioned in this Department letter no.2243 dtd22.01.2003.

This notification shall come into force with immediate effect.
