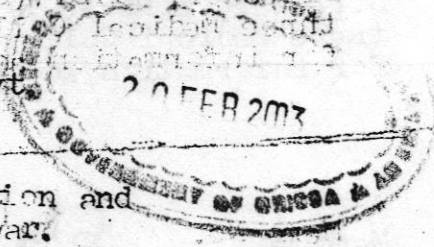

Sub: Reservation of 3% seats in Medical and Para
Medical Institutions for students with
Disabilities, under section 39 of the P.W.D.
Act, 1995.

Sir,

This is regarding reservation of seats for persons with Disabilities in all Medical and Para medical institutions under Health and F.W. Department. In pursuance of the provisions contained in Section 39 of "the persons with Disability (Equal Opportunities, protection of Rights and Full Participation) Act 1995" (A central Act), it has become mandatory on the part of the Government medical Educational Institutions and medical institutions receiving aid from Government to reserve 3% seats for persons with Disabilities during their admission to different medical and paramedical institutions.

Government after careful consideration have decided that the medical and para medical institutions under this Deptt. will strictly adhere to the provision of reservation of 3% seats for admission of the Disabled students into P.G. Medical/MBBS/B.D.S./Pharmacy/Nursing/ DMRT/DMLT etc. courses in an academic year. The provision will be incorporated in the respective prospectus for admission of students to different institutions.

This order supersedes the earlier provision of giving 1% reservation for physical handicapped students at the time of taking admission into aforesaid institutions.

While implementing the above provision, disabled students eligible for getting admission on their own merit will not be counted towards the three percent quota. At the same time, no dilution of the minimum prescribed norms is stipulated for the disabled students.

This order shall be given effect to from the current academic session i.e. 2003-04. This may be intimated to all concerned for its scrupulous implementation.
