#### NOTIFICATIONS

The 10th July 1992

No. 28655—SC-9-4/92-Gen.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa hereby makes the following rules further to amend the Orissa Civil Services (Classification, Control and Appeal) Rules, 1962, namely—

1. (1) These rules may be called the Orissa Civil Services (Classification, Control and Appeal) Amendment Rules, 1992.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Civil Services (Classification, Control and Appeal) Rules, 1962 (hereinafter referred to as the said rules), in rule 6, after clause (ii), the following clause shall be inserted, namely—

“(ii-a) State Civil Services (Specially declared Gazetted)”.

3. In the said rules, in rule 7, for the words and figures “Class I, Class II”, the words and figures “Class I or Class II or the State Civil Services (Specially declared Gazetted) or the State Civil Services Class III” shall be substituted.

4. In the said rules, in sub-rule (1) of rule 8, after clause (ii), the following clause shall be inserted, namely—

“(ii-a) State Civil Posts (Specially declared Gazetted)”.

5. In the said rules, for clause (iv) of rule 13, the following clause shall be substituted namely—

“(iv) recovery from pay of the whole, or part of any pecuniary loss caused to Government, or to a company, association or body of individuals, whether incorporated or not, which is wholly or substantially owned or controlled by Government, or to a local authority set up by an Act of Parliament or of the Legislature of a State, by negligence or breach of orders”.

No. 28658—SC/6-27/92-Gen.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Orissa hereby makes the following rules to amend the Orissa Civil Service ( Rehabilitation Assistance ) Rules, 1990.

1. (1) These rules may be called the Orissa Civil Service ( Rehabilitation Assistance ) ( Amendment ) Rules, 1992.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Civil Service ( Rehabilitation Assistance ) Rules, 1990 ( hereinafter referred to as the said rules ) in rule 2, in clause (a), in sub-clause (iii) for the words, and abbreviation and numerical “up to Rs. 12,000”, the words, abbreviation and numerical “above Rs. 20,000” shall be substituted.

"Notwithstanding the period of limitation prescribed in sub-rules (6) and (7), delay not exceeding twelve months in submission of application for appointment.
