

The Committee will have following Terms of Reference:


- i) To analyze the pendency of DC Bills of different Administrative Departments for last five years.
- ii) Suggest Checks/validations in IFMS to prevent unauthorized drawal of AC Bills.
- iii) Deliberating with Officers of OPSC/OSSC/OSSSC/Chief Electoral Officer/ State Election Commission for graduating to stage of beneficiary payments instead of making advance payment in respect of expenditure related to conduct of recruitment examination/conduct of Election.
- iv) Propose a suitable alternative mechanism for minimising the requirement of drawal of AC Bills.
- v) Deliberate on any other issues related to drawal of AC Bills.




