
**Sub: Implementation of instructions issued by Government in the matter of Premature Retirement/ Out of turn Promotion and Award of Incentives to the Government employees.**

Sir,

I am directed to invite a reference to the above mentioned subject and say that Instructions were issued vide Letter No. 24087 dated 28.10.2020 to all Departments for proper implementation of Instructions in the matter of Pre mature Retirement, Out of turn Promotion, and Award of incentives to the Government employees . In the said Letter, Annexure A has been enclosed which prescribes that a Single Committee may be constituted by the A/Ds for screening of employees for the above four categories. It is seen that this may lead to some issues pertaining to the cases of Group-A (JB) officers. This instruction as contained in Annexure A may please be treated as withdrawn.

Hence it is clarified that the A/Ds may constitute Screening Committees for different categories as prescribed in the relevant OM/ Resolution / Circular in order to finalise the names of the employees in different categories.
