Bhubaneswar , Dated the 15th January ,2022

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Odisha is pleased to make the following rules further to amend the Odisha Civil Service (Fixation of Upper Age Limit) Rules, 1989, namely:-


1. Short title and commencement.— (1) These rules may be called the Odisha Civil Service (Fixation of Upper Age Limit) Second Amendment Rules, 2022.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Civil Service (Fixation of Upper Age Limit) Rules, 1989, after the second proviso to rule 2, the following proviso shall be inserted, namely:—

“Provided also that upper age limit as so fixed in the second proviso shall be applicable to those cases where the last date of application for recruitment to any post as per the advertisement issued is still not over as on the date of commencement of the Odisha Civil Service (Fixation of Upper Age Limit) Amendment Rules, 2022.”

Sir,


In inviting reference to the subject cited above, I am directed to send herewith the copy of Notification No.771/Gen., dated 11.01.2022 issued by this Department relating to the OCS (Fixation of Upper Age) Amendment Rules, 2022.

In order to enable over-aged candidates to take advantage of this relaxation, it is important that the implementation is done in a manner which does not adversely affect the recruitment processes where the recruitment process has already begun.

It is therefore clarified that this notification shall be applicable in those cases where the last date of application for recruitment to any post as per the advertisement issued is still not over, as on the date of issue of this notification.

It is therefore requested to take action accordingly.
